Dear President Obama:

Under the provisions of Section 501 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. sections 5121-5207 (Stafford Act), and implemented by 44 CFR Section 206.35, I request that you declare an emergency for the State of Connecticut as a result of Hurricane Sandy, a very large, dangerous, and unique hybrid storm. The National Weather Service (NWS) forecasts that Hurricane Sandy will impact the entire State beginning this evening and continuing through Wednesday, October 31st. High wind warnings and coastal flood warnings have been issued by NWS for a dangerous storm with major coastal flooding. The State began taking emergency protective measures on October 26, 2012 and these are continuing. The storm's impact as a tropical cyclone storm is forecast to be major and potentially catastrophic, with storm surges that are predicted to be in the range of 6 to 11 feet above astronomic high tide, with 6 to 10 foot waves on top of the surge. Sandy is currently forecast to affect multiple high tides in Connecticut, starting with the high tide Sunday evening. The most destructive flooding is expected with the Monday evening high tide, with the possibility of additional damage during the Tuesday noon high tide. In addition, further damage can be expected from high winds combined with rainfall, with many trees still at full or partial foliage and a moist ground from higher than normal rainfall in October. Given the wind, coastal surge, and flooding impacts on the State's communities, Sandy threatens destruction at the level of a major disaster. Municipalities along the shore are preparing for storm surges at the level of a Category 4 hurricane.

In response to the situation, I have taken appropriate action under state law and directed the activation of the State Emergency Plan on October 26th in accordance with Section 501(a) of the Stafford Act. I have also directed the activation of the State Emergency Operations Center. Under Connecticut General Statutes Section 28-9, I declared a state of civil preparedness

emergency yesterday morning, October 27th, (copy attached) for the whole state in anticipation of the impending severe storm, for the counties of Fairfield, Hartford, Litchfield, Middlesex, New Haven, New London, Tolland, and Windham.

In addition, evacuations for coastal and low lying areas are being ordered throughout Connecticut. These evacuation orders are anticipated to affect approximately 223,000 individuals in the shoreline areas, with over 140,000 individuals from East Haven to Greenwich. We are now learning that evacuations may be needed up to a Category 4, which exceeds over 360,000 individuals. These evacuations are being ordered in at least four counties: Fairfield, New Haven, Middlesex and New London. We are especially concerned about the flooding and coastal surge impacts on densely populated urban areas, including numerous colleges and universities with large student populations.

This declaration is necessary in order to provide operational Federal support (e.g., teams, equipment, supplies) to meet critical emergency protection requirements before landfall of the hurricane, other than pre-positioning, that would overwhelm the capability or capacity of State resources. These requests may include: additional search and rescue resources; emergency communications; Army Corps of Engineers; evacuation resources and support; medical support; emergency power generation; mass care and sheltering support; commodities and distribution; incident management support; and technical and advisory assistance.

Pursuant to 44 CFR Section 206.35, I have determined that this situation is of such severity and magnitude that effective response is beyond the capabilities of the State and affected local governments, and that supplementary Federal assistance is necessary to save lives, protect property, public health and safety, and/or to lessen or avert the threat of a disaster. I am specifically requesting Categories A and B, including Direct Federal Assistance. I have activated the State's pre-executed disaster removal and monitoring contracts pre-landfall in order to prepare for catastrophic debris removal. I am specifically requesting reimbursement at 100% for Categories A and B, including Emergency Protective Measures and Direct Federal Assistance for at least the first 72 hours.

I am specifically requesting this assistance for all counties of Connecticut: Fairfield, Hartford, Litchfield, Middlesex, New Haven, New London, Tolland, and Windham, for the incident period beginning October 27, 2012, and continuing. Tropical force and/or hurricane force winds, rain and flooding are anticipated to affect all counties of Connecticut.

The following information is furnished on the nature and amount of State and local resources that have been used or will be used to alleviate conditions of this emergency:

The State Emergency Operations Center has been staffed since October 26, 2012, with full activation since 0800 October 28, 2011. All state agencies have been engaged in hurricane-type preparedness activities, including: planning for the movement of inmates from low lying facilities; preparing for the evacuation of 19 coastal nursing homes; preparing the volunteer Urban Search and Rescue Team; putting the state's mobile field hospital and Disaster Medical Assistance Team on standby; preparing and staging assets; opening and staffing emergency operations centers, including off-hour activations; ordering and deploying sandbags; preparing state facilities for hurricane-force winds; moving construction equipment, including large cranes at bridge construction sites; deploying cots, cribs, and other assets; preparing for debris removal activities; public messaging; testing equipment; evacuating large animal facilities; re-locating records in flood prone buildings; implementing emergency measures. State chain saw crews are

on standby. The State Fire service has requested a national fire service GO team to assist with incident management support. The State is mobilizing 29 decontamination trailers that also serve as shower facilities and communications assets. Additional mobile communications vehicles are also ready for deployment. State campgrounds and parks have been closed. It is anticipated that MetroNorth train service will be shut down completely, depending on wind speeds and debris. Local resources have been used to prepare for sheltering and evacuations; sandbagging; preparing for debris removal activities, including emergency approval of sites; public messaging; reviewing and implementing SLOSH mapping planning; pre-deployment of assets; equipment preparation and testing. We are working closely with the private sector and with our volunteer partners, such as activation of volunteer teams, including numerous CERT teams, the State Animal Response Team, and Medical Reserve Corps teams; law enforcement, fire, public health and public works activities. In addition to local sheltering, the Red Cross is preparing to open 28 multijurisdictional shelters, with hundreds of volunteers on standby. Substantial pre-landfall support for urban areas evacuation is likely. In addition, we are identifying swift water rescue teams, low draft boats, and high wheel water vehicles.

We anticipate that future pre-landfall activities will further overwhelm the resources of the State. In particular, the cost of the deployment of at least 400 to 1500 National Guard on state active duty to perform extraordinary preparatory activities outside their standard activities is anticipated to be approximately \$100,000-\$300,000 per 24 hour period for staffing alone. In addition, the State has activated its debris removal and monitoring contracts for pre-landfall work at an estimated pre-landfall cost of at least \$100,000. We have purchased 800,000 additional sandbags, as well as leasing fire pumps, forklifts, and pallet jacks. We are ordering water and meals sufficient to feed evacuees and residents for three days.

I certify that for this emergency, the State and local governments will assume all applicable non-Federal share of costs required by the Stafford Act.

I request direct Federal assistance for work and services to save lives and protect property.

- (a) The State requires this assistance in order to help fill the shortfalls in the State's resources. Also, in some cases, the assistance is not likely to be available within the necessary time frame: in other cases, the assistance requires subject matter expertise not otherwise available.
- (b) We have requested that a FEMA Incident Management Assistance Team be deployed to Connecticut, as well as a FEMA State Liaison Officer and a Federal Coordinating Officer, who have arrived in the State EOC today. The National Weather Service has already embedded a meteorologist in our State EOC, providing critical decision support for state leaders. In addition, I am requesting the Coast Guard to be on standby for rescue and other potential missions. I am also requesting the possible availability of an Urban Search and Rescue Team, as most of the state USAR team members are also members of fire or law enforcement departments that have already assigned the individuals locally. I also anticipate that the State will request a certain number of generators, tarps, water, and /or meals, as it is clear that our supplies will be insufficient to meet anticipated need.

In accordance with 44 CFR Section 206.208, the State of Connecticut agrees that it will, with respect to direct Federal assistance:

- 1. Provide, without cost to the United States, all lands, easements, and rights-of-way necessary to accomplish the approved work;
- 2. Hold and save the United States free from damages due to the requested work, and shall indemnify the Federal Government against any claims arising from such work;
- 3. Provide reimbursement to FEMA for the non-Federal share of the cost of such work in accordance with the provisions of the FEMA-State Agreement; and
- 4. Assist the performing Federal agency in all support and local jurisdictional matters.

In addition, I anticipate the need for debris removal, which poses an immediate threat to lives, public health, and safety. Pursuant to Sections 502 and 407 of the Stafford Act, 42 USC Sections 5192 and 5173, the State agrees to indemnify and hold harmless the United States of America for any claims arising from the removal of debris or wreckage for this disaster. The State agrees that debris removal from public and private property will not occur until the landowner signs an unconditional authorization for removal of debris.

The State of Connecticut is currently engaged in recovery efforts on four open federal disaster declarations. Three of these major disasters occurred in 2011, and each was of historic proportions. The state and local cost share for these disasters is estimated to exceed \$50 million. Based on our experience responding to these recent past disasters, we are of the opinion that if this storm is as widespread and damaging as predicted, including record-breaking and potentially catastrophic storm surges, statewide power outages and wind-driven damage to infrastructure. Connecticut simply does not have the resources to adequately respond.

William J. Hackett, State Director of Emergency Management at the Division of Emergency Management and Homeland Security (DEMHS) of the Department of Emergency Services and Public Protection is designated as the State Coordinating Officer for this request. He will work with FEMA in conducting damage assessments and may provide further information or justification on my behalf.
